This chart identifies materials that can be taken year round (unless otherwise noted) to Baltimore County's three residents' drop-off facilities. Questions - please call the Bureau of Solid Waste Management (BSWM) customer service line at 410-887-2000, Mon.-Fri., 7:30 a.m. - 4:00 p.m.

A **<u>Refuse Disposal Authorization** may be needed for certain materials</u> (marked with an \*) or for large amounts of materials or multiple loads. Please see the detailed information regarding the disposal authorization process listed below the chart.

An **R** or **T** in a drop-off facility column indicates the material will be handled as recycling **[R]** or trash **[T]**, respectively, at the specified drop-off facility. An **X** indicates the material is available for pickup by residents. If the column is **blank** the material is **not** accepted at that drop-off facility. **EPS** is the Baltimore County Department of Environmental Protection and Sustainability. **HHW** is Household Hazardous Waste. The full name, address and hours of operation for the drop-off facilities are listed below the chart.

ESL - Eastern Sanitary Landfill Solid Waste Management Facility, 6259 Days Cove Road, White Marsh, MD 21162 (East Side); Mon.-Sat., 7:30 a.m. -3:30 p.m. [depending on the material, you may be directed to the working face of the landfill rather than the drop-off facility]

CAF - Central Acceptance Facility, 201 Warren Road, Cockeysville, MD 21030 (North Central); Mon.-Sat., 7:00 a.m. - 4:00 p.m.

WAF - Western Acceptance Facility, 3310 Transway Road, Halethorpe, MD 21227 (West Side); Mon.-Sat., 7:00 a.m. - 4:00 p.m.

#### **Trash Disposal Information:**

In general, Baltimore County residents in non-commercial vehicles may take up to two (2) loads of trash per week (maximum six [6] loads per year) from their homes in a car, SUV, minivan or pick-up truck (bed 4' x 6' or less) to our facilities without prior authorization (proof of County residency, such as a driver's license, is required). In all other cases, please call the Baltimore County Bureau of Solid Waste Management customer service line at 410-887-2000 to determine if you need a Refuse Disposal Authorization.

#### If a Refuse Disposal Authorization is required:

- allow a minimum of 10 working days from the date of your call until the date you want to drop off your materials;
- you must be the property owner and the property must be your primary residence (as listed on tax records);
- you will be required to prove residency; and
- a collection supervisor will contact you about your request; if the request is approved you will be issued a card with the number of loads approved and the date that the authorization expires.
